



What is an e-Archive Invoice?

An e-Archive Invoice allows the issuing of digital invoices directly for business companies and end consumers who are not included in the e-Invoice scheme, and electronically storing and submitting copies of these invoices.

Legal obligation for e-Archive Invoice taxpayers

As per the legal obligation scope issued by the Revenue Administration (RA), e-Invoice taxpayers are under the obligation to use e-Archive as well. Companies operating in industries specified by the Revenue Administration are also obliged to use the e-Archive Invoice application by the specified deadline, regardless of their yearly turnover.

In addition, regardless of the yearly turnover threshold, companies that would like to have an edge over time, costs and workload can also start using the e-Archive Invoice solution optionally.

e-Archive Invoice transition steps

Businesses that would like to use e-Archive Invoice or that are obliged to use e-Archive Invoice should be an e-Invoice user. Therefore, the only thing that should be done by businesses which are the users of eLogo e-Invoice is to contact eLogo to start using the e-Archive Invoice solution.

Documents are approved with financial seal and time stamp before storage.	Documents are signed using financial seal, time stamp is not necessary.
Used with confirmation from the company's own IT systems or private integrator.	One of the RA Portal, integration or private integrator methods is used.
