



During a workplace's operational performance, all employees (permanent or temporary), together with subcontractor employees, visitors, customers and every other person within the boundaries of the working space, are included in the scope of OHS. Therefore it is the purpose of OHS to specify and improve all the factors which might affect the health and security of these persons.




Legal context

Workplaces that are required to acquire OHS services, as per the circular published by the Ministry of Labor and Social Security (MLSS) on February 27th, 2018, are also required, from July 1st, 2018 onwards, to electronically submit data requested by the Ministry of Labor and Social Security via integrators authorized by the Ministry. Digitalizing this process brings considerable speed and convenience to OHS applications.

The eLogo OHS solution, developed in line with this purpose, can be used by workplace physicians and on-site occupational safety specialists, as well as those working at the Common Health and Safety Units.

Although not included in this scope, Common Health and Safety Units (CHSUs) and individually serving Occupational Safety specialists and workplace physicians can also utilize this solution.



Why eLogo OHS?

Designed in line with the Law No. 6331 on Occupational Safety and management systems, such as OHSAS 18001 and ISO 14001, eLogo OHS manages all processes related to occupational safety and occupational health (infirmary and e-Prescription procedures) on a web-based platform in full compliance with current legislation. In other words, all legislative changes are automatically reflected into eLogo OHS.

With multi-language support, eLogo OHS can also be used conveniently in multinational businesses. eLogo OHS also fulfills the legal obligations of submitting obligatory data to the Ministry of Labor and Social Security and storing this data for 10 years.






Comprehensive process management

When data is entered into the system, eLogo OHS can be used to analyze every process. These analyses identify risks and unpredictable outcomes, based on which proactive measures can be developed to improve processes and mitigate risks. In addition, company-specific risk databases can be generated and place and activity-based risk scoring can be performed for risk analysis. Risk assessment forms and other reports can be easily created in the system.

Following up on the documentation related to health reports, training statuses and work accidents of every employee in a business means a considerable workload and the need for a physical archive area.eLogo OHS enables the display of these documents in the system which makes for an easier and more effective process, saving time both for employees and managers.

With eLogo OHS software you can also define training sessions provided and send these to the Ministry of Labor and Social Security directly through the system. In addition, training certificates and annual work plans can be converted into MS Word, Excel or PDF formats and printed or stored in the system.

Along with the occupational safety applications, eLogo OHS also includes occupational health functions catered for workplace physicians. Processes such as recruitment, return-to-work, periodical examinations, polyclinic examinations and creating prescriptions/e-Prescriptions can be performed on the Infirmary module of eLogo. Work accident notifications can be made using the Event/Accident Notification module.

While the workplace physicians can easily print the APPENDIX-2 form and prescriptions through the system, they can also manage appointments. Workplace physicians can also define appointment frequencies directly on eLogo OHS, which facilitates orderly management of all health check appointments in the business. Workplace physicians are also reminded automatically of due dates for examinations, vaccinations and appointments.
